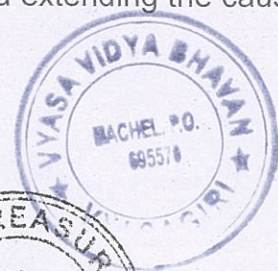
AFFIDAVIT
